## When Will Our Branch Lobbies Reopen?

Many of you have been asking when LVECU will reopen our lobbies to members again. Believe us when we say we want this just as badly as you do.

You may have heard that Lehigh and Northampton Counties moved from the "Red" phase to "Yellow" on Friday, June 5, 2020. Under Yellow, we will continue conducting transactions through our drive-thrus and require appointments for new accounts and lending in our lobbies.

Once our region moves to the "Green" phase, we will slowly reintroduce lobby teller, member service and coin machine transactions using the guidance provided by the CDC and government officials.

That will mean:

- · Adding protective barriers at teller stations and desks
- Wearing masks (employees and members)
- Limiting the number of people allowed in the branch at one time
- Practicing social distancing

## We Want to Help You

Your well-being as an LVECU member matters to us. We understand many of our members are struggling to make ends meet right now, and we have your back. Please let us know how we can help you. We will be as creative as possible to offer solutions that get you through this tough time.

Here are some things we are doing already that you may not know about.

In March, we began offering hardship loan payment deferments and fee waivers when requested by members. Please call us if you are struggling to make your LVECU loan payments.

LVECU lifted the federal transaction limits imposed on savings accounts, which allow no more than six withdrawals or transfers per month via debit card, check, or internet, telephone, and preauthorized (ACH) transfers. This gives you greater, more convenient access to your money.

If you have an auto loan with another lender, we may be able to lower your monthly payment by refinancing it. Lower interest rates usually mean lower payments. A title transfer fee is required.

## Annual Meeting

The Lehigh Valley Educators Credit Union Annual Meeting was scheduled for Saturday, March 14, 2020, but was cancelled due to the coronavirus. The meeting was rescheduled for Wednesday, June 3, 2020, and held via WebEx. There were 29 scheduled attendees, but only 17 attended: eight Board members, two Management employees and seven members. President William Ayers called the meeting to order at 10:01 am. He reviewed highlights of the annual reports, and Chief Financial Officer Ron Houck reviewed the credit union financials. Daniel Weaver, Nominating Committee Chairperson, presented the slate of directors, who were unopposed. Eugenia Emert, Gary Fedorcha and Gary Phillips were elected to the Board for a three-year term. Director Daniel Joseph recognized the scholarship winners. Mr. Joseph informed attendees that over the past 19 years, LVECU has awarded over \$185,000 in scholarships to students.

## Protect Yourself Against COVID-19 Scams

Criminals are using people's fears of COVID-19 to steal their personal information. The latest scam involves people on Medicare.

Scammers are offering COVID-19 tests to Medicare patients in exchange for personal details, including their Medicare information. **These tests are fake!** 

Scammers are targeting Medicare recipients through telemarketing, text messages, social media and even door-to-door.

#### Protect yourself or your loved ones:

- Never give your Medicare number to anyone unless you call them for something
- · Don't agree to unsolicited testing or medical supplies
- · Do not respond to or open hyperlinks in text messages or emails about COVID-19
- · Ignore offers or advertisements for COVID-19 testing or treatments on social media sites
