

Important Tax Information

Tax forms (1099-INT, 1099-R, 1098)* will be mailed to all qualifying members by January 31, 2023.

*1099-INT: Earned more than \$10 of dividends in 2022

1099-R: Made an IRA withdrawal in 2022

1098: Paid more than \$600 in interest on a home equity loan in 2022

Information About Your IRA

April 17, 2023 is the last day to make Traditional or Roth IRA deposits for the 2022 tax year. Your contribution to a traditional IRA could reduce your taxable income by the amount of the contribution and reduce the amount you owe in taxes. If you owe money on your tax return, check to see if opening an IRA or contributing to your existing IRA will reduce that burden. Why not pay yourself before you pay the government?

When mailing IRA deposits, always indicate the tax year to which you would like the deposit contributed. Statements for IRA balances will be mailed by May 31, 2023.

Taxpayers beware: Tax season is a prime time for phone scams

With tax season right around the corner, the IRS reminds taxpayers to be aware that criminals continue to make aggressive calls posing as IRS agents in hopes of stealing taxpayer money or personal information.

The IRS will never:

- Call to demand immediate payment using a specific payment method such as a prepaid debit card, gift card or wire transfer. The IRS will first mail a bill to any taxpayer who owes taxes.
- Threaten to immediately bring in local police or other law enforcement groups to have the taxpayer arrested for not paying.

What to do if you receive these phone calls?

- Keep the number for your records and hang up the phone immediately.
- Report the call on the U.S. Inspector General website or call 800-366-4484.

- Demand that taxes be paid without giving taxpayers the opportunity to question or appeal the amount owed.
- · Call unexpectedly about a tax refund.
 - Report number to phishing@irs.gov and put "IRS Phone Scam" in the subject line.

Protect your debit card with an app on your phone

Take control of spending and fraudulent activity on your LVECU debit card. CardValet is a free app that lets you:

- · Submit a travel notice
- Turn your debit card ON/OFF
- · Control purchases by dollar limits, merchant categories and geographic locations
- Get alerts when your debit card is used, approved or exceeds your set transaction controls.
- · Stay aware of potential fraud with alerts on attempted and declined transactions
- Get real-time balances for your accounts
- · Control family spending on sites where your debit card is saved
